# UNGA

## UNITED NATIONS GENERAL ASSEMBLY

***Agenda: Deliberation upon the Global Arms Trade and the Usage of Private Military Companies with Special Emphasis on the USA Second Amendment.***

The UNGA convenes to address the complex and pressing issue of the global arms trade and the rising use of private military companies (PMCs), with special consideration of the United States' Second Amendment. As international conflicts grow increasingly privatized and weapons circulation transcends borders, delegates will examine the legal, ethical, and security implications of unregulated arms flows and PMC operations. This session aims to balance national sovereignty and constitutional rights with global peace, accountability, and human rights protections.





# UNESCO

**UNITED NATIONS EDUCATIONAL, SCIENTIFIC  
AND CULTURAL ORGANIZATION**

***Agenda: Deliberation upon Preserving Cultural Integrity and  
Personal Privacy in the Age of Social Media.***

In an era where social media shapes global narratives and influences cultural exchange, UNESCO addresses the growing challenge of preserving cultural identity while safeguarding personal privacy. # WHO

**WORLD HEALTH ORGANIZATION**
