### **Agenda: Deliberation over the Sudan crisis with special emphasis on the division of military power and roles**

The Republic of Malta is deeply concerned about the ongoing Sudan crisis and its ramifications for regional stability, human rights, and the well-being of the Sudanese people. As a member of the United Nations Security Council (UNSC), Malta believes that addressing the Sudan crisis requires immediate attention and concerted international efforts. In this position paper, Malta outlines its perspective on the division of military power and roles in Sudan, underscoring the importance of inclusive dialogue, respect for human rights, and regional cooperation as crucial components in achieving a lasting and sustainable solution..

Malta seeks to promote a comprehensive approach that tackles the root causes of the conflict, protects civilians, and lays the foundation for peace, stability, and development in Sudan. - Advocate for the professionalization, accountability, and respect for human rights within the Sudanese Armed Forces (SAF) and other military groups.
- Engage with the African Union (AU), the Intergovernmental Authority on Development (IGAD), and other relevant stakeholders to support regional peace initiatives.
- Promote effective coordination and information-sharing among peacekeeping forces, humanitarian actors, and local communities.
- Encourage disarmament, demobilization, and reintegration programs for armed groups.
