Besides laws, Morocco has also teamed up with organizations like the **International Organization for Migration (IOM)** to help prevent trafficking and support migrants. We've done awareness campaigns too — especially for young women and girls in rural areas.

### 4.UN's Role and Morocco's Support

The United Nations has done a lot in this area, like setting up the **Palermo Protocol** and encouraging countries to follow **Sustainable Development Goal 5.2**, which talks about ending trafficking and violence against women.

Morocco supports these actions and tries to follow these international standards. We've taken part in UN conferences and shown our support for plans that protect women's rights, especially those related to migration.

### **5.Morocco's Suggestion**

Even though Morocco is still learning and improving its systems, we believe some good steps can be taken, like:

- Improving communication between countries to stop trafficking groups across borders
- Helping women through education and job training so they don't fall into dangerous traps
- Making safer ways for women to migrate legally
- Giving full support to victims medical, legal, emotional
- Teaching people, especially in small communities, about what trafficking is and how to report it
